Registration of Sole Proprietorship Business in Hong Kong

Registration Procedures

When you engage Kaizen to register your sole proprietorship business, please follow the procedures described below.

- 1. You place an order with Kaizen for the registration of sole proprietorship with payment of fees;
- You provide to Kaizen the following information by email or fax: 2.
 - (1) Proposed name of the sole proprietorship;
 - (2) Name, residential address and Hong Kong identity card number of the owner (sole proprietor);
 - (3) Detailed business address of the proposed sole proprietorship business;
 - (4) Business nature of the sole proprietorship;
 - Commence date of the sole proprietorship (5)
- According to the information in point 2, Kaizen fill out and deliver the original registration application form to you by post;
- You sign the application form and return it to Kaizen together with a photocopy of the sole proprietor's Hong Kong identity card by post;
- Kaizen arranges to submit the registration application form to the Business Registration Office and at the same time, make the payment of business registration fee;
- Kaizen collects the Business Registration Certificate and forward it to you.
